

ACQUISITION STRATEGIES



Most work is competed - limited Sole Source awards

- Use sole source in many cases to get new contractors doing work for the Norfolk District
- 17 new contractors added to the pool in FY20,
 FY21: Goal is 10 more new contractors

Currently no pool of MATOCS to support SRM like work

- FY21 efforts to build more tools Road Repair MATOC for ANC
- JOC in place to support Defense Supply Center Richmond \$25M
- 2 Sole Source D-B SRM Contracts to be put in place Northern VA(Quantico, FT A.P. Hill, Dahlgren) and Hampton Roads
- IFB most used stand alone C-Contracts
- Increased use of IFB with Definitive Responsibility Criteria DRC
 - Bridge between IFB and BVTO quicker, provides assurance we are awarding to capable firms
 - Contractors asked to provide evidence that they can do the work after bid opening
 - Generally asking for specific relevant past experience; narrative that explains they understand the project and key technical challenges, etc.
 - "...the Contracting Officer will also examine whether the low bidder can meet the requirements of the solicitation by demonstrating that the prime contractor or subcontractor responsible for dredging has dredged by mechanical means or hopper a minimum of 80,000 cubic yards in a consecutive 30-day period in a cold-weather month (October through January) withdisposal/placement onto a beach. This will be considered a definitive responsibility criterion"





AE INDUSTRY DAY FEEDBACK

- Innovation often first thing to go in VE Study need to do better at programming this in the 1391 – VE doesn't gain value – it just cuts costs up front
- Compressed design schedules notdesired, but if needed – eliminate the 65%
- On-Board Reviews effective if done right need to get everyone in the room
- Cyber Criteria is a concern not well defined we are all learning
- Pre-proposal meetings are extremely helpful— we will continue to do them
- BIM Models not always shared with the construction contractor – we will share moving forward

COST ROUNDTABLE FEEDBACK


- Use Draft RFPs helps contractors in bid proposals an area where we continue to focus – more coming
- Share the bid data with the AEs they need feedback on their estimates –we weren't sharing
- Government needs to better develop PAs and 1391s everyone needs to be involved up front in the charrettes
- Current market conditions are resulting in lots of Above the Threshold Reprogramming – (lower of \$2M or 25% of PA)
- AEs would like two weeks after design submittal to provide the cost estimate will get a better number
- Why do we require CDs on BID day? Hard to produce at last minute many computers don't' have CDs – eliminating this requirement
- Need to do better in award process shouldn't take months to award after BIDs are in – results in increased costs from subs
- Government needs to better communicate ATRs and timelines Can we inform all
 of apparent winner at start of ATR Process? Frees up others to pursue other work,
 helps winner keep subs on board looking into a path forward to meet the intent
- Schedule isn't a good factor for evaluation in a BVTO procurement
- Options costs are inflated to account for risk award in 120 days or do apost award mod
- Procurement strategy is a key component in a contractor's go/no decision to bid on a project

- What is the USACE Office of Small Business Programs (OSBP)?
 - The purpose of the OSBP is to assist in the development of small businesses by maximizing their opportunities to participate in USACE procurements, thereby ensuring a broad base of capable suppliers to support the Corps of Engineers' mission and strengthen our nation's economic development.
- How does the Deputy of Small Business Programs at the Districts and Centers assist small businesses?
 - Small Business Deputies work with the project delivery teams (PDTs) to determine acquisition strategies, which includes making recommendations for sole source and set-aside procurements. Their input is vital to ensuring the Districts meet and/or exceed their annual small business goals.



What Can You Do?

- Check Beta.Sam.gov, eBuy and SubNet websites frequently
 - ✓ Search using the respective District's Department of Defense Activity Address Code (DODAAC). Ex. Norfolk District is W91236
 - ✓ Event Brite- Facebook Twitter Linked In
 - ✓ Respond to Sources Sought Notices
 - ✓ Establish and build relationships with large and small businesses
- Keep information current in System for Award Management (SAM) and in the SBA's Dynamic Small Business Search
 - ✓ We can't award to you if you are not in the system.
 - ✓ Keep marketing materials and Business Cards up to Date



What Can You Do? (cont.)

- Follow Instructions in solicitations documents and Market Research /Sources Sought.
 - ✓ If solicitation has 10 page limit, stay under 10 pages!
 - ✓ Answer specific questions
 - ✓ Utilize bidder inquiry opportunities to gain clarification, don't assume!
 - ✓ Take advantage of site visit opportunities.
- Ask to be Debriefed...
 - ✓ Even if you are the awardee.
- Utilize your resources and ask questions
 - ✓ SBA Business Opportunity Specialists
 - ✓ Small Business Professionals
 - ✓ Stay current with regulatory requirements
 - ✓ Procurement Technical Assistance Centers (PTAC)
 - √ Keep up on regulation changes



Bona fide office rule

8(a) Awards- Sole Source or Competitive

Before an 8(a) award can be made, SBA determines if the Participant (firm in the 8(a) Program) is **ELIGIBLE** for the award.

SBA reviews offer letters against its' 8(a) BD Program Criteria to include 4 items:

- (1) Qualifies as a small business under the NAICS code for to the requirement;
- (2) Compliance with any applicable competitive business mix targets established or remedial measure imposed by§124.509 that doesn't include denial of future sole source 8(a) contracts;
- (3) Compliance with continued eligibility reporting requirements-§124.112(b);
- (4) Has a bona fide place of business in the applicable geographic area if the procurement is for construction;



New Bona Fide Office Request Process

Participant sends Bona Fide Office request to the Servicing BOS. BOS gathers Bona Fide Checklist items and sends request to reviewing office.

If request is for a specific requirement, then request must have been submitted 20 working days before award or offering.

The reviewing office will decide whether the Participant has a bona fide place of business in the district office or Metropolitan Statistical Area.

Participant is required to notify servicing SBA of new location within 30 days of existence.

Reviewing Office will notify servicing BOS of determination. Servicing BOS will annotate the approval of Bona Fide Office in appropriate data collection sited and notify Participant of approval.

Determination must be made within 15 working days of the request or within 5 working days of a site visit.



Bona fide office rule

(4) Has a bona fide place of business in the applicable geographic area if the procurement is for construction;

(k) In order to be awarded a sole source or competitive 8(a) construction contract, a Participant must have a bona fide place of business within the applicable geographic location **determined by SBA**. Geographic location can be:

- The geographic area serviced by the SBA district office,
- A Metropolitan Statistical Area (MSA),
- A contiguous county (whether in the same or different state),
- Or the geographical area serviced by a contiguous SBA district office to where the work will be performed.
- SBA may determine that a Participant with a bona fide place of business anywhere within the state (if the state is serviced by more than one SBA district office), one or more other SBA district offices (in the same or another state), or another nearby area is eligible for the award of an 8(a) construction contract.



Bona fide office rule

BLUF- Clarification is needed on paragraph K of the CFR because there may be several different interpretations.

There are different interpretations from SBA offices about paragraph K.

What constitutes nearby city?

Some SBA offices are interpreting the "SBA District Office" to mean just the individual SBA District Office servicing the 8a firm, while others view this to mean the SBA Region in which the SBA office is a part of.

Is the assessment of bona fide office on a sole source construction requirement supposed to be done on a project by project basis? How does this apply to pre-approving 8a vendors for work in certain states/areas.

A-E TASK ORDER SELECTION PROCEDURES

The TORN shall include:

- 1. Short summary of the scope of work and expected AE tasks
- 2. Selection criteria
- 3. Request for Supplemental Information tailored to the specific TO requirement **or** Notification that the firms will be evaluated based on the SF330 on file
- 4. Due date



SUMMARY OF THE SCOPE OF WORK AND EXPECTED AE TASKS

Summary of Scope of Work

- Information should provide the AE a quick snapshot of the project and identify what makes it unique or difficult.
- Include the expected POP or important Milestone dates
- The Construction Cost Limit

The Expected AE tasks

 Design Documents, Design-Build Technical RFP package, Programing support, ITR Support, Construction support, Archeological survey, etc.



TORN SELECTION CRITERIA

- 1) Professional Qual:
- 2) Specialized Experience:
- 3) Capacity:
- **4) Past Performance Eval:** The AE should not provide anything for this criteria
- 5) Location in the Geographic area or Knowledge of Location



EXAMPLE EVALUATION CRITERIA

Professional Qual:

- A well-defined Quality Control process with defined Roles and Responsibilities.
- Professional qualifications necessary for satisfactory performance of historic preservation
- AE shall identify the project manager or lead for the proposed project.
- Resumes for key personnel (no more than 2)

Specialized Experience:

- Specialized experience in the museums and historic preservation/conservation disciplines
- Experience with design of conditioned aircraft hangars for the Department of Defense that included high expansion foam fire suppression systems

Capacity:

- Confirm that the AE has the capacity to complete the work within the expected POP
- Capacity to complete the three building designs of this magnitude, on separate sites, within the required time frame to include proposed staffing plan. Targeted date for Ready to Advertise submittal will be 14 January 2021 with a 10 – 11month period of performance.

Location in the Geographic area or Knowledge of Location:

AE demonstrate DEQ experience within relevant watershed areas.



TORN

- Submission of new SF330 is NOT required for each TO unless requested by TORN.
- The responses should be limited to 1-3 pages but will be defined in TORN.
- Requests for information is the same for each firm in the MATOC.
- The AE should be able to provide the information within 5 business days.
- After the AE is selected the non-selected AE's will be notified for the AE Selection and AE's can request a debrief.

Major Changes coming soon to SAM.gov and Beta.SAM.gov; two phase process

Closeout is a critical function of the Acquisition Process

Requires attention to detail and timely responses.

Task Required by Contractors:

- Final Invoice
 - Check for accuracy
 - Identify the invoice as the final invoice
- Release of Claims
 - You will receive a release of claims from the Government or a Government Contractor
 - Please verify the information is correct and respond timely





ADDITIONAL ITEMS TO REMEMBER

Contractor Performance Assessment Reporting System (CPARS)

- Please ensure your Contracting Officer's Representative has a good POC to receive and respond to CPARS.
- Timely responses are needed in order to closeout CPARS.
- Communication with the COR is key.

Contractor Manpower and Reporting

Contractor Manpower Reporting is now found within SAM.GOV it is no longer eCMRA
